# Introduction

Cyber Information Security Leader (CISL) is an educational program designed to train cybersecurity managers and specialists, enabling them to safely lead organizations through the challenges of digitalization.

Despite the high priority of cybersecurity among top management, many professionals still encounter significant barriers when managing cybersecurity. Often recruited from specialist roles, they commonly face two main shortcomings: understanding business language and logic, and corporate governance.

As cybersecurity becomes increasingly decentralized and relevant to multiple organizational business functions, the ability to drive change and facilitate collaboration, communication, and commitment is becoming central to their responsibilities. This can be an overwhelming challenge. Therefore, these skills hold a prominent position among other subjects in the CISL program.

The CISL program focuses on strengthening participants' capabilities to navigate the new corporate landscape managing business strategy, politics, risks, stakeholders, crises, culture, and executive reporting.

With an emphasis on personal leadership, participants are also introduced to the value of understanding how personality types, their capabilities, and their behavioral structures can be strategically used to create impact and drive results, especially in crisis situations.

After the program, participants will have gained the insight and ability to handle the complex challenges surrounding their roles.

# About the Program

## Approach

The CISL program employs a combination of lectures, guest speakers, real-life cases, and exercises provided by instructors to facilitate open discussions. Participants will be assigned to groups and are expected to actively engage in various exercises. Additionally, participants are expected to allocate time for group work between modules as part of their preparation.

## Prior to the Program Start

Participants will complete an initial coaching session to define individual learning objectives and development areas. Two additional coaching sessions will follow up on individual development during the program.

## Program & Modules

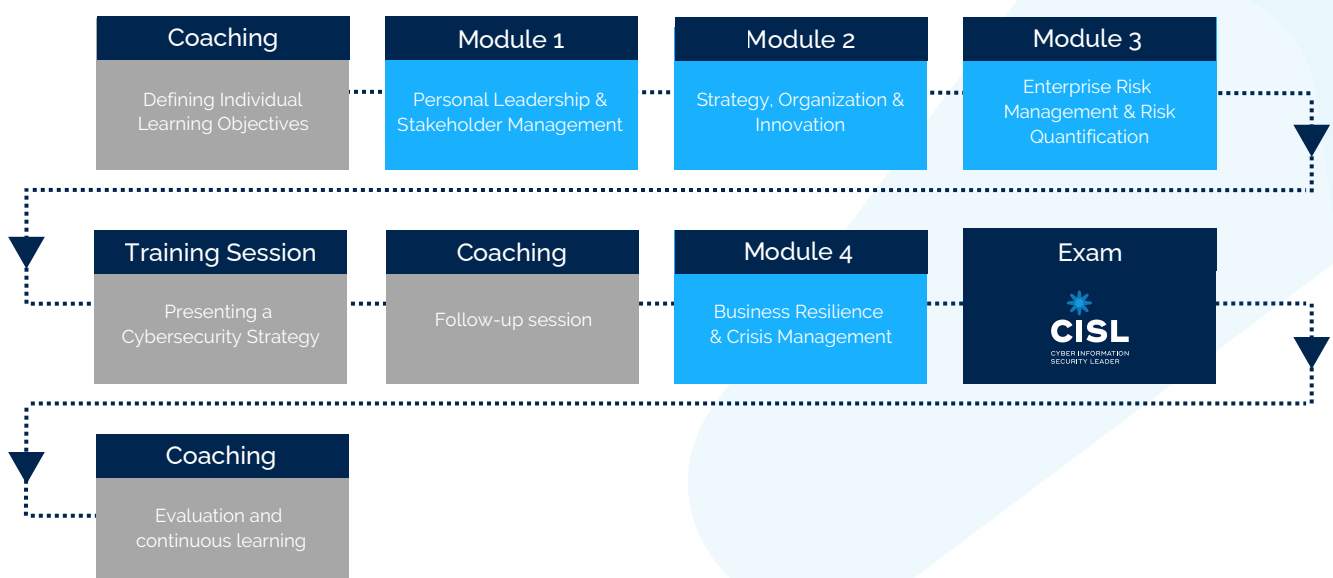
The program comprises of 9 full-course days. Course days are divided into 4 themed modules and a training session. Module 1, 3 and 4 constitute residential courses to promote a strong network and to foster ongoing dialogue among participants.

The program ends with a final individual exam, where participants will present a business case to a fictitious 'Board of Directors'. To pass the program and qualify for the exam, participants must attend at least 8 out of the 9 course days.

## CISM Training (Optional)

# Modules & Learning Objectives

## Module 1: Personal Leadership & Stakeholder Management

This module introduces key concepts and frameworks to guide effective communication with teams and organizational stakeholders - foundational elements of the CISL program. The module presents the Enneagram as a framework for understanding individual leadership capabilities, challenges, and different communication styles to manage relationships and conflicts more effectively. As stakeholder management is key to success in change management, the module explores essential aspects of stakeholder communication, equipping participants with strategies to build trust and practical techniques for engaging, convincing, and influencing key stakeholders.

**Keywords:** Foundational Frameworks, Personal Leadership, The Enneagram, Stakeholder Management, Stakeholder Communication, and Change Management.

**Outcome:** Participants will gain the skills to tailor communication strategies that resonate with stakeholders, enabling them to craft a compelling and recognizable narrative, appeal to relevant business drivers, and build trust to drive greater engagement, support, and impact.

## Module 2: Part 1: Strategy & Organization

This module explores the business strategy and organizational landscape of executive stakeholders. With insights into the mindset, roles, priorities, and decision-making processes of executives, the module illustrates ways to improve communication and frame the cybersecurity agenda in a way that resonates with top management—securing alignment, commitment, and buy-in for cybersecurity initiatives. The module will also cover key principles for designing a cybersecurity function that fits the organization. Addressing questions of references, headcounts, governance, and design, participants will get inspiration for how to build a cybersecurity organization that not only supports the business but serves as a strategic enabler of resilience.

**Keywords:** Business Strategy, Executive Mindset, Executive Communication, Board of Directors, Cybersecurity Reporting, Governance Structures, and Cybersecurity Organization and Design.

**Outcome:** Participants will get perspectives on how to strengthen collaboration and communication with executive stakeholders with greater impact.. align cybersecurity efforts—including organizational design and governance structures—with broader business priorities.

# Modules & Learning Objectives

## Module 2: Part 2: Strategy & Innovation

This module deepens the exploration of the organizational landscape with a focus on understanding organizational mechanisms and the intersection between business strategy, digital strategy, and cybersecurity strategy. Recognizing how these strategies connect is essential to understanding what drives the organization and how to align efforts effectively. Participants will learn the importance of ensuring cybersecurity is in sync with the broader organizational goals and how to make cybersecurity an enabler of digitalization and innovation efforts and create meaningful dialogues and collaborations across various business units. Based on the introduced frameworks, participants will later be presented with a key assignment in presenting a cybersecurity strategy that connects with their organization.

**Keywords:** Business Strategy, Cybersecurity Strategy, Digital Strategy, Innovation, Digitalization, Organizational Alignment, and Business Drivers.

**Outcome:** Participants will gain strategies to align cybersecurity with the digital agenda and broader organizational goals, positioning it as an enabler of business growth and innovation. They will learn to identify key initiatives that support these objectives while fostering collaboration across business units.

## Module 3: Enterprise Risk Management & Risk Quantification

This module provides participants with the knowledge to navigate the complex threat and risk landscape across the entire value chain. Emphasizing cyber risk within the broader enterprise risk management framework, the module focuses on clear and compelling communication to executives, aligning with business priorities and securing resources for mitigation. It also covers the development and frameworks to measure and report cybersecurity risks and progress in a way that resonates with executive stakeholders. Participants will explore methods for quantifying risks, assessing potential consequences, and leveraging e.g. Business Impact Analysis (BIA) as a key tool to prioritize and design effective risk mitigation strategies.

**Keywords:** Enterprise Risk Management, Cyber Risk, Risk Mitigation, Risk Reporting, Risk Quantification, and Business Impact Analysis (BIA).

**Outcome:** Participants will gain models to assess enterprise risks and think Business Impact Analysis into risk management practices. They will also learn how to map and prioritize cyber risk against enterprise risk in communication with senior executives.

# Modules & Learning Objectives

## Module 4: Business Resilience & Crisis Management

This module explores best practices in crisis management and business continuity, and how to ensure business resilience in crisis situations. It introduces models and plans for crisis response and disaster recovery, highlighting the importance of training, effective communication, clear ownership, defined escalation paths. The module provides inspiration on how continuous training can be done with simple practices and gamification to improve organizational resilience over time. Through a crisis simulation exercise, participants will test their ability to navigate a chain of events and maintain composure under pressure. They will receive feedback on their communication, collaboration, and leadership to increase self-awareness and improve techniques in leading through disruptions with minimal impact.

**Keywords:** Business Continuity, Crisis Management, Crisis Response, Disaster Recovery, Contingency Planning, Organizational Resilience, Crisis Communication, Continuous Training and Crisis Simulation.

**Outcome:** Participants will gain practical insights into crisis management and business continuity, learn how to foster a culture of continuous training to strengthen organizational resilience, and enhance their ability to lead through high-pressure situations with confidence.
